Registration and scholarships

To access the 2nd year of the Finance Finance Quantitative Finance Master's degree: The candidate comes from the 1st year of the Master's degree in Finance. The selection in this sector is based on a special test to ensure that students have sufficient prerequisites to follow the teachings of the specialty (very high level in mathematics and computer science). In the context of external recruitment: the candidate must demonstrate scientific training and:

- * Have at least a 1st year Master's degree in mathematics and / or computer science
- * Or have validated a 2nd year of engineering school with a strong mathematics and / or computer component

Public continuing education : You report continuing education:

if you resume your studies after 2 years of interruption of studies,

- or if you followed a formation under the regime formation continues one of the 2 preceding years
